Meter must also be made available for periodic inspection by a Marco employee when notified / requested.

METER SHALL BE READ THE 1ST AND NO LATER THAN THE 5TH OF EACH MONTH.

You will need to take a picture of the reading on the meter and E-Mail it in to me at: karenmr@marcoruralwater.com. If I do not receive a reading each month, you will be billed for 0 usage, and when it is turned in you will be billed for total usage from the last reading in our system up through the reading when turned in.

Marco has the right to request recovery of hydrant meter if bill is not paid by the 5th (Due Date) of each month. A late fee of \$15.00 will be added if paying after 8:00 A.M. on the following business day after the 15th of each month. It is **your** responsibility to protect the fire hydrant and meter from any/all damage. If there are damages, you will be charged accordingly.
